Terms and Conditions for Senoko Energy x Tiger BOSS Debit Card Promotion

Eligibility

- 1. The Tiger BOSS Debit Card Promotion ("Promotion") is available from 3 Nov 2025 to 31 Mar 2026 (both dates inclusive) ("Promotion Period").
- 2. The Promotion is open to the **first 250 customers** who are new or renewal customers of Senoko Energy Supply Pte Ltd ("Senoko Energy") (collectively, "Eligible Senoko Customers") and principal cardholders of Tiger BOSS Debit Cards ("Cards") issued by Tiger Brokers (Singapore) Pte Limited ("Tiger Brokers") (collectively, "Eligible Cardmembers").
- 3. By participating in the Promotion, the customers agree to be bound by these terms and conditions.

Promotion Mechanics

- 4. Under this promotion, an Eligible Senoko Energy customer can get a **one-time bill rebate of \$130** ("Rebate") if he/ she renews or signs up via self-help online channels for a twenty-four **(24) months** Senoko Energy residential electricity price plan ("Senoko Energy Plan") if he/she fulfils the following:
 - a) Within the eligible sign-up period, be the **first 250 customers** to renew or sign-up via self-help online channels and input the promo code "**TGBKYE130**" ("Promo Code") during the sign-up process and
 - b) successfully set up Debit Card recurring payment using Tiger BOSS Debit card within 1 month from sign up date
 - c) Senoko Energy will award the Rebate to the Eligible Senoko Customers' bill as follow:
 - i. For sign-up period: 3 Nov 30 Nov 2025, the rebate will be credited latest by Jun 2026
 - ii. For sign-up period: 1 Dec 30 Dec 2025, the rebate will be credited latest by Jul 2026
 - iii. For sign-up period: 1 Jan 31 Jan 2026, the rebate will be credited latest by Aug 2026
 - iv. For sign-up period: 1 Feb 28 Feb 2026, the rebate will be credited latest by Sep 2026
 - v. For sign-up period: 1 Mar- 31 Mar 2026, the rebate will be credited latest by Oct 2026
- 5. For the avoidance of doubt, this promotion is not applicable to existing Senoko Energy customers with service contracts that are auto-renewed.
