

Fund Mall x Grab Promotion

Terms and Conditions:

Definitions:

Customer or Customers, shall refer to the users of the Tiger Trade Application offered by Tiger Brokers (Singapore) Pte Ltd

Fundmall, refers to the unit trust or mutual fund investment functions available on Tiger Trade

Grab Rewards Points or GRP, shall means the reward points issued by Grab Singapore.

Grab, shall refer to Grab Singapore

Investment or Investment Fund, in this terms and conditions shall only refer to Unit Trust or Mutual Funds available on Tiger Trade application.

Organizer, shall refer to Tiger Brokers (Singapore) Pte Ltd

Tiger Trade, refers to the investments application provided by Tiger Brokers (Singapore) Pte Ltd for users to use as their investments and trading needs.

Qualified Funds, refers to the Investment Funds purchase during the promotion period which is from the 22nd of November 2021, to 31st December 2021.
