

Tiger Brokers GEAR UP with DLC Campaign

Terms & Conditions

1. Tiger Brokers GEAR UP with DLC Campaign

- 1.1 The Tiger Brokers GEAR UP with DLC Campaign is valid for the period from 13th September 2021 to 22nd October 2021 (both dates inclusive).
- 1.2 DLC (Daily Leverage Certificates) are categorized as SIPs (Specified Investment Products); which may only be suitable for clients who have met CAR (Customer Account Review) requirements.
- 1.3 'Eligible Participants' are defined as new or existing Tiger Brokers (Singapore) Pte Ltd (TBSG) clients who trades DLC listed on SGX for the period from 13th September 2021 to 22nd October 2021 with a weekly total contract value of not less than S\$500 in value.
